### **Official Photo Entry Rules and Regulations**

1. Entries must include a complete entry form. To protect photos, entries should be packaged with appropriate cardboard stiffeners, and if mailing slides, place them in plastic sleeves to preserve them. The entry form must be firmly attached to the back of the photograph and/or plastic sleeve and can be mailed or delivered to Mornington Communications, 16 Mill Street East, Milverton, Ontario, N0K 1M0. Digital photos can be emailed to [amustard@mornington.ca](mailto:amustard@mornington.ca).
2. Entries must be submitted by November 5, 2010 and do not necessarily need to be taken in the 2010 calendar year. Mornington Communications is not responsible for entries that are lost, late, delayed, misdirected, unintelligible, illegible, incomplete, postage due, stolen, returned, separated, damaged or undeliverable entries or mail.
3. There is no limit to the number of entries per person. Each submission must include a separate entry form (or reproduction of facsimile). Photos containing identifiable people must also be accompanied by a model release form. Model release forms are the responsibility of the entrant and must be available if the photo is chosen. Numerous entries can be submitted in on envelope.
4. Acceptable entries must be in colour, or black & white unmounted prints or mounted transparencies/slides. Digital entries not submitted electronically on the website must be submitted on a minimum 5x7 print using photo quality paper. The original file resolution must be a minimum of 3.1 megapixel and submitted as a .jpg, .gif or .png file. The digital print should match the quality and character of the original digit capture. Compositional changes to the digital files are not acceptable and will be disqualified; tonal or colour cast corrections are acceptable. For all entries, original material, including original negative and/or capture file must be available for reproduction purposes. All entries and material received become the property of Mornington Communications and will not be returned.
5. For an entry to be considered it must be an original, unpublished photograph taken within Perth County.
6. By signing the entry form, the entrant grants Mornington Communications the unrestricted and exclusive right to use the photograph(s) for any purpose. This includes, but is not limited to, publishing your photograph(s) in print or electronic form for promotional purposes without further compensation, and the right to use the photographers name as a credit along with the photograph. The photographer must own the rights to any photographs submitted. It is the responsibility of the entrant to ensure that publication of the photograph raises no
