Your Monthly Bill

- System Access & 911 fees are recurring monthly charges unless they are included in your monthly rate.
- One time Activation Fee.
- Your monthly rate plan fees are subject to GST & PST.
- On your first bill there will be charges for services used between your activation date and billing date.
- Your bill will include charges for services and features which are billed one month in advance, as well as additional usage charges such as long distance, roaming, additional airtime usage, text messaging, picture and video messaging and any mobile browsing usage charges that are not already part of your services.
- Your bill will arrive monthly and is due on the 26th of the month. If payment is received after the 26th of the month, a late payment charge will be applied to the account.
- Early Termination Fee: The fee payable by you if your service is terminated before the expiry of your term of 12, 24, or 36 months. The Early Termination Fee is the greater of (i) \$100 or (ii) \$20 per month remaining in the Term upon termination, to a maximum of \$400. The Early Termination Fee may vary depending on promotional offers.

15 Day/15 Minute Refund Policy

If you are not completely satisfied with your services, you may terminate by cancelling your services and returning your equipment within 15 days of its purchase date or 15 minutes of use, whichever occurs first, to the original point of purchase. A refund will be issued for equipment in "like new" condition with all components, manuals, and original packaging. You are responsible for the payment of the monthly package service charge, 911 emergency service fee, system access fee and for any airtime, long distance, data transfer, roaming, and any other charges you have incurred.

IMPORTANT: Pay Per-Use Data and Mobile Browsing Charges

USING CERTAIN FEATURES, SERVICES AND APPLICATIONS ON OR WITH YOUR DEVICE, AND DOWNLOADING CONTENT, MAY RESULT IN PER KILOBYTE DATA TRANSPORT CHARGES. PLEASE ASK A CUSTOMER SERVICE REPRESENTATIVE FOR EXAMPLES OF PER-USE DATA TRANSPORT CHARGES.

You can subscribe to Unlimited Mobile Browsing for unlimited mobile browser usage for a flat monthly fee, including the data transport service required to download ring tones, screensavers, games, applications, music, instant messaging, and for any other services using mobile browsing for data transport. Without Unlimited Mobile Browsing, data transport charges (currently 5¢/KB) will apply when you use any feature or service using data transport. For example; current average kilobyte usage to check your horoscope = 10KB (50¢), download a ring tone = up to 145 KB (\$7.25) PLUS the cost of the ring tone (currently up to \$4.00) or download a full track song = 1000 KB (\$50.00) PLUS the cost of the song (example \$3.00). **You acknowledge that without Unlimited Mobile Browsing you are liable for and agree to pay Mornington's current per kilobyte charge for data transport services.**

Even if you subscribe to Unlimited Mobile Browsing, if you use your device as a modem for a PC or other device you will be charged additional data transport charges at Mornington's then current per-kilobyte data transport rates. **You acknowledge and agree to pay these charges.**

If you have activated a data device, you will be charged for data transmission from or to the device (including through "teethering" the device to a PC or other device) such as sending and receiving emails, at Mornington's then current per kilobyte data transport rates. If you subscribe to a data plan, you will be charged additional per kilobyte rates as set out in the plan, for any data transport usage in excess of the data transport included in the monthly plan data plan fee. **You acknowledge and agree to pay these charges.**

Additional data roaming charges may also apply, **including to the use of Unlimited Mobile Browsing.**
